Terms and Conditions for all Traders trading at the Bluff Flea Market

Annexure A - Rules and Regulations - to be amended as as when required.

- 1. All Traders and Customers must comply to Covid Protols.
- 2. Wear a mask at all times in public, social distance and sanitize responsibily
- 3. All traders must ensure at least a metre length is between themselves and the next Trader
- 4. Permanent traders of the ex Dutch Club will be allowed to setup in their old Trading spots within the demarkated Flea Market grounds only, this is subject to change accordingly to municipal requirements
- 5. No trading will be allowed in the parking area or the entrance of the premises
- 6. Traders vehicles must be parked in the allocated Traders Parking with exception of the verge and boundary stalls, overflow will be allowed at the back of the grounds
- 7. Customer parking will start in the front demarkated entrance and overflow will carry on in the back of the grounds. Customers will not be allowed to park on the road.
- 8. Portable toilets will be provided onsite
- 9. No Alcohol will be allowed on the premises whether in consumption or sale
- 10. All traders must get their own bins to keep in their stall for themselves and their customers
- 11. At the end of trade, all dirt must be deposited in the designated area for municipality pick up
- 12. Setup can be from 5am onwards and trading will close by 4pm (adjustable seasonal/functions)
- 13. All traders must comply to health and safety protocols
- 14. All traders trade at their own risk, neither is the Municipality or the The Bluff Flea Market Committee Members, Managers and or staff will be held accountable for any losses.
- 15. Traders will not be allowed to trade without an Informal Trading Permit
- 16. Traders will not be allowed to trade without paying the upfront Management Fee
- 17. Second hand sales of goods will not be allowed without a second hand goods permit if you are a registered Company
- 18. Monies will not be collected from Traders at the entrance, all payments must be made prior to trading
- 19. Walk in / Drive in on the day traders will not be allowed, however if they are selling second hand goods, they are welcome to approach the Auction Stall and see if they wish to sell their goods via Auction
- 20. If it rains on Trading day and you are unable to trade, you will not be refunded, however the amount you pay upfront is for 3 months, worked at 4 weeks in the month, so in the months that have 5 weeks, you will not be asked to pay more in either Management or Licence fees.
- 21. Management Fees collected will be used to manage the grounds to employ and pay for a Manager, cleaning staff and essentials
- 22. Food stall must comply to covid protocols and health & safety Fire Extinguisher, plastic or clear shields in front separating your food display / sale between you and the customer, wear gloves while serving, no open fires allowed, no alcohol sales we will advise further should Municipality require further protocols
- 23. Please bear with us while we get started and please be patient and understanding while we get measures in place
